SECTION C DESCRIPTIONS AND SPECIFICATIONS

1.0 BACKGROUND

The Office of Naval Research (ONR) coordinates, executes and promotes the science and technology programs of the United States Navy and Marine Corps through schools, universities, government laboratories and non-profit and for-profit organizations. ONR formulates and executes the Naval Science and Technology (S&T) portfolio to address the most responsible and promising technology opportunities and solutions in both basic and applied science; transitions the most useful technologies to Acquisition and the Warfighter; and provides technical advice and information to the Chief of Naval Operations (CNO), the Secretary of the Navy, and the Department of Defense.

Under ONR's Director of Technology, the Disruptive Technologies (DT) Division, Code 03T-DT, manages the "Leap Ahead Innovations" and "Quick Reaction & Other S&T" focus areas of ONR's overall Strategy.

- DT Mission: The DT Division is dedicated to identifying, funding and managing the development, experimentation, and analysis of innovative technologies to improve the capabilities of the warfighter in the short and long term.
- DT Vision: The DT portfolio of programs delivers innovative and new capabilities and technologies to ensure the warfighter is never in a fair fight. These programs push the boundaries of Science and Technology to deliver transformational warfighting capabilities and prototypes. Ranging from rapid, fleet responsive programs to high risk, game changing technologies that can dramatically change the way naval forces fight, the

DT portfolio consists of paradigm breaking, pioneering programs. The future of the Navy resides in the technologies and capabilities being created and developed within the DT portfolio. The DT team is dedicated to ensuring the creation, development, demonstration, and transition of effective technologies and capabilities that run the gamut from rapid prototypes to longer term, interruptive, and state of the art solutions.

The Director of Disruptive Technologies oversees the DT organization consisting of Innovative Naval Prototypes (INP), Leap Ahead Technologies, Technology Innovation (innovation outreach), Operations Analysis (OA) that includes technology innovative games (TIG), ONR Experimentation (OE), TechSolutions (TS), Department of the Navy (DON) Rapid Prototyping that includes legacy CNO Speed-to-Fleet using budget activity (BA) 4 funding, and Joint Technologies leveraged with the Office of Secretary of Defense (OSD). ONR management oversight is not limited to the above and additionally covers the SwampWorks (SW) program and other program elements as required. These various programs and processes capitalize on knowledge combined with technology and state of the art to reach the warfighter with products designed to enhance capabilities and maximize effectiveness. Technology investments are potentially "game changing" or "disruptive" in nature.

2.1 Objective

The purpose of this task order (also referred to herein as “contract”) is to provide technical, program management and financial analyst support to the Director of Disruptive Technologies (03T-DT) and to the Director of Technology, Director of Research, and the Chief of Naval Research.

The Director of Disruptive Technologies requires a variety of services to support the execution and seamless operation of, but not limited to, the following programs: Innovative Naval Prototypes, Leap Ahead Technologies, Technology Innovation (innovation outreach), Operations Analysis that includes technology innovative games (TIG), ONR Experimentation, TechSolutions, DON Rapid Prototyping that includes legacy CNO Speed-to-Fleet using Budget Activity (BA) 4 funding, Joint Technologies leveraged with OSD, and SwampWorks.

2.2 Scope

The Contractor shall provide the Director of Disruptive Technologies with technical, program management and financial analyst support that reflects the unique breadth of the DT Division responsibilities, including support of strategic planning activities, execution and management of ongoing and planned programs, technical reviews and assessments, technology innovative games including war-gaming, innovation outreach, internal communications including external partnership engagements, and organizational outreach across the Naval Enterprise and Department of Defense. The contractor must have a highly experienced team to provide budgetary, analytical, editorial, technical and general support to the DT Division in accordance with Section 2.3 below. Performance of tasks shall conform, at a minimum, to the performance standards and acceptable quality levels identified in the Quality Assurance Surveillance Plan (QASP) that will be contained in the subsequent award.

2.3 Technical Tasks/Requirements

The contractor shall provide support in the yearly planning, facilitation, and execution of programs such as Innovative Naval Prototypes, Leap Ahead Technologies, Technology Innovation (innovation outreach), Operations Analysis, ONR Experimentation, TechSolutions, Department of the Navy (DON) Rapid Prototyping, Joint Technologies, and SwampWorks.

The contractor’s support tasks shall include, but not be limited to the following areas:

2.3.1 Innovative Naval Prototypes (INP): Provide monthly monitoring and Command reporting as required. Provide technical, program management and financial analyst support, and general support of the day to day program oversight, execution, and coordination tasking. This includes scheduling and conducting technical and programmatic individual program reviews throughout the year for each Innovative Naval Prototype and providing presentations, fact sheets, and outreach materials.

2.3.2 Leap Ahead Technologies: Provide monthly monitoring and Command reporting as required. Provide technical, program management and financial analyst support, and general support of the day to day program oversight, execution, and coordination tasking. This includes scheduling and conducting technical and programmatic individual program reviews throughout the year for each Leap Ahead Technology and providing presentations, fact sheets, outreach materials, and website content.

2.3.3 Technology Innovation (innovation outreach): The contractor shall assist in the execution of innovative venues designed to create an innovative dialogue for the DT Division and ONR leadership. Foster, provide, and support technology innovation events/summits, workshops, and tasks forces enabling current/future analysis, development, and experimentation. Provide presentations, fact sheets, outreach materials, and website content.

2.3.4 Operations Analysis (OA): The contractor shall assist with operational analysis through studies, workshops and gaming to assist with identifying Navy and Marine Corps capability needs that can be addressed with S&T solutions. The contractor shall assist in the coordination, support, organization of conducting special studies, workshops, and/or war-games including technology innovative games (TIG). Specifically, plan, facilitate, execute, attend and provide status reports on technology innovative games (TIG).

2.3.5 ONR Experimentation (OE): The contractor shall assist in capitalizing on recent technology breakthroughs to develop prototypes quickly and provide them to the warfighter for experimentation during laboratory and operational demonstration, sea trials or level of efforts. The contractor shall provide monthly monitoring and Command reporting as required. The contractor shall provide technical, program management and financial analyst support, and general support of the day to day program oversight, execution, and coordination tasking including presentations, fact sheets, outreach materials, and website content.

2.3.6 TechSolutions (TS): The contractor shall assist in the development of rapid response S&T solutions to immediate Fleet/Force needs identified by individual warfighters at the deck-plate level. The contractor shall provide technical, program management and financial analyst support, and general support of the day to day program oversight, execution, and coordination tasking including presentations, fact sheets, outreach materials, and website content.

2.3.7 Department of the Navy (DON) Rapid Prototyping: The contractor shall provide technical, program management and financial analyst support, and general support of the day to day program oversight, execution, and coordination tasking as required by ONR. This may include, but not limited to, legacy CNO Speed-to-Fleet (S2F) initiatives and investments along with providing presentations, fact sheets, and outreach materials.

2.3.8 Joint Technologies: The contractor shall assist in the ability of ONR to leverage technologies with OSD to achieve dominant capabilities through prototyping, experimentation

This includes, but is not limited to, OSD Joint Capability Technology Demonstrations (JCTD) and Rapid Reaction Technology (RRT) programs. Provide monthly monitoring and Command reporting as required including presentations, fact sheets, and outreach materials.

2.3.9 SwampWorks: The contractor shall assist in seeking to develop and demonstrate technologies that address emergent and enduring operational problems in an accelerated timeframe. Provide monthly monitoring and Command reporting as required. Provide technical, program management and financial analyst support, and general support of the day to day program oversight, execution, and coordination tasking including presentations, fact sheets, outreach materials, and website content.

2.3.10 Other Program Elements and Initiatives: The contractor shall support the yearly planning, facilitation, and execution of other ONR program elements and initiatives as required by the DT Division. The contractor shall provide monthly monitoring and Command reporting as required. Provide technical, program management and financial analyst support, and general support of the day to day program oversight, execution, and coordination tasking. This includes scheduling and conducting technical and programmatic individual program reviews throughout the year and providing presentations, fact sheets, outreach materials, and website content.

2.3.11 Communication Support: The contractor shall provide strategic communications to include the preparation of speeches, correspondence, presentations, outreach materials, reviews, website graphics or content and reports. The contractor shall provide planning, facilitation, and execution of ONR organizational outreach venues and engagements where the DT Division is required to foster and attend. For informational data calls both internal and external, the contractor shall assist in the gathering of data and response material for, but not limited to, Congressional requests, OPNAV Taskers, and other Governmental requests for information.

The contractor shall perform other tasks as deemed appropriate, necessary, and assigned by the Director of Disruptive Technologies, which are within the scope of work of this effort.

3.1.2 Parking and Local Transportation

a) Inherently Governmental Functions – No inherently government functions as defined in FAR 2.101 and FAR 7.5 are to be performed by the contractor or contractor personnel performing under this contract. Contractor employees shall not participate in any deliberations or meetings intended to exercise an inherently governmental function. All final determinations such as binding the United States to take or not to take some action, selecting program priorities, and providing direction to Federal employees shall be made by the government. The contractor shall immediately notify the Contracting Officer's Representative (COR) and the Contracting Officer if performance of an activity would result in the performance of an inherently governmental

function.

b) Non-Personal Services Contract – In accordance with FAR 37.101, this contract is a non-personal services contract. Contractor personnel rendering the services shall not be subject, either by the contract's terms or by the manner of its administration, to the continuous supervision and control of a Government officer or employee. The Contractor shall immediately notify the COR and the Contracting Officer if, through contract administration, the actions of a government employee will result in the performance of a personal services contract.

c) Identification of Contractor Personnel – In accordance with DFARS 211.106, contractor personnel shall never identify themselves as representing the Office of Naval Research (ONR), but rather shall identify themselves as being under contract to ONR. 3.0 KEY PERSONNEL

a) The Contractor agrees to assign to the contract tasks those persons whose resumes were submitted with its proposal and who are necessary to fulfill the requirements of the contract as "key personnel." No substitutions may be made except in accordance with this clause.

b) The Contractor understands that during the first ninety (90) days of the contract performance period, no personnel substitutions will be permitted unless these substitutions are unavoidable because of the incumbent's sudden illness, death or termination of employment. In any of these events, the Contractor shall promptly notify the Contracting Officer and provide the information described below. After the initial ninety (90) day period the Contractor must submit to the Contracting Officer all proposed substitutions, in writing, at least 30 days in advance (45 days if security clearance must be obtained) of any proposed substitution and provide the information required by paragraph below.

c) Any request for substitution must include a detailed explanation of the circumstances necessitating the proposed substitution, a resume for the proposed substitute, and any other information requested by the Contracting Officer. Any proposed substitute must have qualifications equal to or superior to the qualifications of the individual proposed at the time of proposal submission. The Contracting Officer or his/her authorized representative will evaluate such requests and promptly notify the Contractor in writing of his/her approval or disapproval thereof.

d) In the event that any of the identified key personnel cease to perform under the contract and the substitute is disapproved, the contract may be immediately terminated in accordance with the Termination clause of the contract.

e) Contractor employees who wish to attend ONR organizational events, such as a picnic or holiday party, must seek approval to do so from the Contractor. The government will not reimburse the Contractor for the cost of labor or any other expense associated with attendance at such events.

f) Authorization for government personnel to depart early for reasons unrelated to the closure of government offices (e.g., granted 59 minutes) shall not apply to Contractor employees. The government will not reimburse the Contractor for the cost of labor or any other expense associated with the early departure of its employees under such circumstances.

g) The Contractor is responsible for the management of its employees, including approving absences for sickness, training, and vacation; however, the Contractor will inform the COR of the absence. 6.0 HOURS OF OPERATION
